## DIRECTIONS

**From the North:** Take GA 400 South; Exit at #5 Abernathy Road;  
Right onto Abernathy Road; get in left turn lane;  
Left on Barfield Road, 1<sup>st</sup> light;  
Right on Hammond Drive, 2<sup>nd</sup> light; cross Roswell Road;  
Right on Lake Forrest Drive, 3<sup>rd</sup> light;  
Left at Century Springs East driveway to park.

**From the Northeast:** I-85 South to I-285 West; Exit at #25 Roswell Road/Sandy Springs;  
Right on Roswell Road;  
Left on Hammond Drive, 2<sup>nd</sup> light;  
Right on Lake Forrest Drive, 3<sup>rd</sup> light;  
Left at Century Springs East driveway to park.

**From the East:** I-20 West to I-285 North; Exit at #25 Roswell Road/Sandy Springs;  
Right on Roswell Road;  
Left on Hammond Drive, 2<sup>nd</sup> light;  
Right on Lake Forrest Drive, 3<sup>rd</sup> light;  
Left at Century Springs East driveway to park.

**From the South:** I-75 North to I-85 North to GA 400 North and through toll plaza;  
Take I-285 West; Exit at #25 Roswell Road/Sandy Springs;  
Right on Roswell Road;  
Left on Hammond Drive, 2<sup>nd</sup> light;  
Right on Lake Forrest Drive, 3<sup>rd</sup> light; left into Century Springs East.

**From the Southwest:** I-85 North to GA 400 North and through toll plaza;  
Take I-285 West; Exit at #25 Roswell Road/Sandy Springs;  
Turn right on Roswell Road;  
Turn left on Hammond Drive, 2<sup>nd</sup> light;  
Turn right on Lake Forrest, 3<sup>rd</sup> light; left into Century Springs East.

**From the West:** I-20 East to I-285 North; Exit at #25 Roswell Road/Sandy Springs;  
Turn left on Roswell Road;  
Turn left on Hammond Drive, 3<sup>rd</sup> light;  
Turn right on Lake Forrest, 3<sup>rd</sup> light; left into Century Springs East.

**From the Northwest:** I-75 South to I-285 East; Exit at #25 Roswell Road/Sandy Springs;  
Turn left on Roswell Road;  
Turn left on Hammond Drive, 3<sup>rd</sup> light;  
Turn right on Lake Forrest, 3<sup>rd</sup> light; left into Century Springs East.
