DANGEROUS PRODUCT: BE ON THE LOOKOUT

The attorneys and staff of J. Franklin Burns, P.C. want to keep clients abreast of recent developments in the law and about potentially dangerous products that could cause harm to former clients or their families or friends. One such product is the IVC filter that is sold by various big medical device companies. An IVC (inferior vena cava) filter is a medical device that is surgically implanted into the inferior vena cava to prevent life threatening pulmonary emboli from traveling to the lungs, resulting in death.

The FDA has increasing concerns about the safety of IVC filters, particularly those manufactured and marketed by C. R. Bard and Cook. Serious health complications, such as filter migration, filter fracture, filter perforation, filters breaking, hemorrhage, heart or lung perforation, heart and chest pain, stroke and death have been attributed to these dangerous products.

If you, a loved one, or a friend has received one of these IVC filters, you may be entitled to payment whether you are experiencing symptoms or not; however, **DON'T GO IT ALONE.** At J. Ingredients: (Serves 10)

18 ounces white chocolate chips or dark chocolate chips (a bag and a 1/2)

1. Pre-heat oven to 150 degrees.


